The company APF DIGITAL AGRIFUND CR s.r.o. values your trust and places great importance on the protection of your data, including personal data, during processing. The company APF DIGITAL AGRIFUND CR s.r.o. processes all personal data exclusively in accordance with the legal regulations governing the protection of personal data and takes care to protect personal data in accordance with valid and effective legislation, which since 25 May 2018 is represented in particular by the EU Regulation 2016/679 (General Data Protection Regulation, abbreviated "GDPR"), which is supplemented in the Czech Republic by the accompanying Act on the processing of personal data.

The purpose of this declaration is to inform you about the processing of personal data that occurs in connection with visiting the website of the company APF DIGITAL AGRIFUND CR s.r.o. (www.apfdigitalagrifund.com), as well as about some other cases of processing of personal data where the activities of the company APF DIGITAL AGRIFUND CR s.r.o. involve the processing of personal data of other persons (e.g., clients, journalists, etc.).

Processing of log files

1.1. In the context of access to its website, the company APF DIGITAL AGRIFUND CR s.r.o. processes log files on access to this website in order to protect its legitimate interests in ensuring the protection of the website and improving its functioning.

1.2. The log files are thus processed without the consent of the website visitor and are stored for 1 month after the visit to the website.

1.3. The processing of these log files will be carried out by the company APF DIGITAL AGRIFUND CR s.r.o. itself, which is; processing of the log files, the company APF DIGITAL AGRIFUND CR s.r.o. processes the following data, which may (but need not) include personal data of the website visitor:

the website from which the visitor visited the website of the company APF DIGITAL AGRIFUND CR s.r.o.;

- IP address;
- access date and access time;

any question from the visitor;
reply code http;
transferred data groups;
information about the browser and operating system of the website visitor's computer.

Processing of personal data for sending newsletter enquiries and processing of personal data from enquiries from other websites

2.1. In case of interest of the website visitor in sending an inquiry via the contact form, the company APF DIGITAL AGRIFUND CR s.r.o. will process the personal data provided by such visitor for these purposes, always at least in the scope of the e-mail address and telephone number. If the visitor also provides the company APF DIGITAL AGRIFUND CR s.r.o. with their identification data (first name, surname), the company APF DIGITAL AGRIFUND CR s.r.o. will also process this data for these purposes. The content of the newsletter may be personalised on the basis of the data provided and other data for the personalisation of the content that the company APF DIGITAL AGRIFUND CR s.r.o. obtains from the visitor's behaviour on the website.

2.2. The company APF DIGITAL AGRIFUND CR s.r.o. will start processing the visitor's personal data only after the visitor fills in their data in the contact form and confirms the submission of the contact form. If the inquiry in the contact form is not confirmed, the data entered by the visitor in the form will be destroyed without undue delay. Personal data is processed for the legitimate interest of recording and processing the visitor's requests and for the purpose of capturing the visitor's expressions of intent.

2.3. The company APF DIGITAL AGRIFUND CR s.r.o. is entitled to ask the website visitor how they will finance the purchase price of the property or cooperative share in order to fulfil the obligation of the company APF DIGITAL AGRIFUND CR s.r.o. – intermediary arising from Section 2452 of Act No. 89/2012 Coll., Civil Code and to fulfil the obligations arising from Act No. 253/2008 Coll.

2.4. Personal data is processed until the newsletter is cancelled. The actual processing of the personal data provided will be carried out by the company APF DIGITAL AGRIFUND CR s.r.o. itself or by a third party, in particular another company from the APF GROUP. You can unsubscribe by clicking on the link "Unsubscribe APF DIGITAL AGRIFUND CR s.r.o. Newsletter" in the sent newsletter.

Processing of personal data in connection with the sale, purchase, lease of real estate or cooperative shares

3.1. In the case of concluding a brokerage agreement, purchase agreement, purchase contract or delivery of the ordered services, the company APF DIGITAL AGRIFUND CR s.r.o. will process the personal data of the client in the scope of name, surname, e-mail address, telephone contact and address. For the purpose of drafting contractual documentation, the company APF DIGITAL AGRIFUND CR s.r.o. may require the provision of personal data in the following range: bank account and national identification number. These personal data are processed by the company only for the purpose of drafting the contractual documentation and are not further processed by the company.

3.2. The company APF DIGITAL AGRIFUND CR s.r.o. will process the aforementioned personal data of clients in order to implement the concluded brokerage agreement, purchase agreement, purchase contract, delivery of ordered services, and last but not least, in order to protect its rights and legally protected interests consisting in protection against possible litigation arising from the concluded contracts or agreements mentioned above. The company APF DIGITAL AGRIFUND CR s.r.o. is entitled to ask the client who is buying how the purchase price of the property or cooperative share will be financed in order to fulfil the obligation of the company APF DIGITAL AGRIFUND CR s.r.o. – intermediary arising from Section 2452 of Act No. 89/2012 Coll., Civil Code and to fulfil the obligations arising from Act No. 253/2008 Coll.

3.3. The company APF DIGITAL AGRIFUND CR s.r.o. makes and keeps copies of clients' identity cards, which are provided by the client only for the purpose of contractual documentation and their unambiguous identification. Copies of clients' identity cards are no longer processed by the company Agrární půdní fond s.r.o. Unless making a copy of the document is a necessary condition for the provision of the service, only a copy of the data from the identity card may be made.

3.4. The company APF DIGITAL AGRIFUND CR s.r.o. will process the above personal data of customers for a period of 10 years from the conclusion of the relevant contract or agreement referred to in point 3.1. The actual processing of the personal data provided will be carried out by the company APF DIGITAL AGRIFUND CR s.r.o. itself or by a third party, in particular another company from the APF GROUP.

3.5. The e-mail addresses and telephone numbers of customers who enter into a contract or agreement referred to in point 3.2 with the company APF DIGITAL AGRIFUND CR s.r.o. are further processed by the company APF DIGITAL AGRIFUND CR s.r.o. for the purpose of verifying customer

satisfaction with the provision of services. The legal title of this processing of e-mail addresses and telephone numbers is thus the protection of the legitimate rights and interests of the company APF DIGITAL AGRIFUND CR s.r.o. consisting in providing feedback on the course of service performance to customers and thus the possibility to improve its offer and services. It is thus a non-consensual processing, since without the e-mail addresses with customer phone numbers it would not be possible to ensure their feedback.

3.6. The company APF DIGITAL AGRIFUND CR s.r.o. will carry out the feedback and thus the processing of e-mail addresses and telephone numbers of customers by itself or it will delegate this to a third party, in particular another company from the APF GROUP.

Processing of personal data during enquiries on the hotline +420 734 154 897.

4.1. In the event of a client's enquiry on the hotline, the company APF DIGITAL AGRIFUND CR s.r.o. will process the personal data provided by such client, to the extent provided by such client in the call, due to the legitimate interest related to the registration and processing of the client's requests and for the purpose of capturing the client's expressions of will.

4.2. The company APF DIGITAL AGRIFUND CR s.r.o. is entitled to ask the client who inquires on the hotline how they will finance the purchase price of the property or cooperative share, in order to fulfil the obligation of the company APF DIGITAL AGRIFUND CR s.r.o. – intermediary arising from Section 2452 of Act No. 89/2012 Coll., the Civil Code, and to fulfil the obligations arising from Act No. 253/2008 Coll.

4.3. The company APF APF DIGITAL AGRIFUND CR s.r.o. will process the aforementioned personal data of customers for a period of 3 years from the call referred to in point 3.1. The actual processing of the personal data provided will be carried out by the company APF DIGITAL AGRIFUND CR s.r.o. itself or by a third party, in particular another company from the APF GROUP.

Processing of personal data in connection with the handling of requests, enquiries and complaints

5.1. The company APF DIGITAL AGRIFUND CR s.r.o. values its customers very much and has therefore set up a customer line. Through this customer line, customers and other persons can contact the company APF DIGITAL AGRIFUND CR s.r.o. with their questions and requests, either by phone, e-mail or by mail delivered by the postal service provider.

5.2. In order to respond to queries and requests addressed to the company APF DIGITAL AGRIFUND CR s.r.o., the company APF DIGITAL AGRIFUND CR s.r.o. will process the personal data provided by the person who raised the query or request. The company APF DIGITAL AGRIFUND CR s.r.o. will process the personal data provided in this way only to the extent necessary (provided) and only until the query or request is processed, unless there is a need to process the personal data for another purpose (for example, to protect the rights and legally protected interests of the company APF DIGITAL AGRIFUND CR s.r.o.). These personal data are provided to the company APF DIGITAL AGRIFUND CR s.r.o. voluntarily, since without their knowledge the company APF DIGITAL AGRIFUND CR s.r.o. would not be able to process the enquiry or request, and therefore this is non-consensual processing.

5.3. The processing of the provided personal data will be carried out by the company APF DIGITAL AGRIFUND CR s.r.o. itself. If it is appropriate or necessary, the company APF DIGITAL AGRIFUND CR s.r.o. is entitled, for reasons of legitimate interest, to transfer the processed personal data to its suppliers for the purpose of dealing with an enquiry, request or complaint.

Processing of personal data in connection with providing consent for sending marketing or commercial communications

6.1. In the event that the client is interested in sending marketing or commercial communications, the company APF DIGITAL AGRIFUND CR s.r.o. will process, on the basis of consent, the personal data provided by such visitor for these purposes, always at least to the extent provided by the client. If the visitor also provides the company APF DIGITAL AGRIFUND CR s.r.o. with their identification data (first name, surname, date of birth), the company APF DIGITAL AGRIFUND CR s.r.o. will also process these data for these purposes.

6.2. The personal data provided are processed until the consent given is withdrawn. The actual processing of the personal data provided will be carried out by the company APF DIGITAL AGRIFUND CR s.r.o. itself or by a third party, in particular another company from the APF GROUP.

Consent to this processing of personal data (including the transfer to a company of the APF GROUP) is entirely voluntary and may be withdrawn at any time, both by sending a notice of withdrawal of consent in writing to the address of the registered office of the company APF DIGITAL AGRIFUND CR s.r.o. (see below) and by sending a notice of withdrawal of consent to the e-mail address info@apfcrypto.com. Without consent, the company APF DIGITAL AGRIFUND CR s.r.o. cannot send advertising communications.

Use of cookies and website analysis

7.1. The company APF DIGITAL AGRIFUND CR s.r.o. uses cookies on its website to improve the functioning of its website, to evaluate its traffic and to optimize its marketing activities. Cookies are small text files that are stored locally by the browser on the computer used to view the website.

7.2. Cookies do not serve and do not allow personal identification of website users. A list of all cookies that the company APF DIGITAL AGRIFUND CR s.r.o. collects on its website is available [here](#).

7.3. If a visitor to the website does not consent to the collection of cookies, they can prevent the collection of cookies by changing their browser settings. For instructions on how to deactivate and remove cookies, please refer to the help of the respective browser or contact the browser manufacturer.

Google Analytics and Google Adwords

7.4. The company Agrární půdní fond s.r.o. uses Google Analytics Premium, developed and operated by the company Google Inc., with its registered office at Amphitheatre Parkway, Mountain View, CA 94043, USA ("Google"), to analyse the website using cookies.

7.5. The analysis by Google Analytics is carried out by transferring the information about the use of the website generated by the collected cookies to a Google server in the USA and analysing it there. As a result of the anonymisation of IP addresses set up on the APF DIGITAL AGRIFUND CR s.r.o. website, the IP address is shortened before the data is transmitted to the Google server in the USA by Google in an EU or European Economic Area member state. Only in exceptional cases is the full IP address transferred to a Google server in the USA and only there is it shortened (anonymised).

7.6. Google will not combine the transmitted data, including the shortened IP address, with other data. Google's privacy statement can be viewed [here](#).

7.7. Visitors to the website can prevent the collection and analysis of cookies by Google Analytics by changing their browser settings, as described above, and by:

by installing the browser plug-in available [here](#). This plugin only works in the respective browser on the respective computer and must not be deactivated or deleted after installation in order to preserve the deactivation of Google Analytics.

7.8. As part of Google Analytics, the company APF DIGITAL AGRIFUND CR s.r.o. also uses related advertising functions provided by Google, such as

reports of impressions in the Google advertising network, enhanced reporting of anonymous demographic data (e.g., age, gender, interests) or displaying ads in the content network based on products viewed (the so-called remarketing), including Google AdWords, which is used to personalize advertising and improve ad targeting and remarketing. This enables it to offer visitors to its website the most interesting advertising content possible.

7.9. Visitors to the APF DIGITAL AGRIFUND CR s.r.o. website can disable or modify the personalisation of advertising via their Google account using the link available here.

8.2. Please bear in mind that these social plugins are not managed by the company APF DIGITAL AGRIFUND CR s.r.o., which is therefore not responsible for any processing of personal data by the aforementioned operators

(administrators) of these plugins or the websites to which they link, nor for their functionality and any damage they may cause.

Processing of personal data of journalists

9.1. Journalists can contact the company APF DIGITAL AGRIFUND CR s.r.o. via the e-mail address info@apfdigitalagrifund.com in connection with their profession. In this case, the company APF DIGITAL AGRIFUND CR s.r.o. processes their (provided) personal data for the purpose of responding to their enquiry.

9.2. The personal data area provided voluntarily by the journalists and without their knowledge, the company APF DIGITAL AGRIFUND CR s.r.o. would not be able to handle their inquiry, therefore it is non-consensual processing. The response to the journalist's inquiry itself is stored in the system of the company APF DIGITAL AGRIFUND CR s.r.o. for 90 days and is subsequently deleted or anonymised. The identification data and the journalist's area of interest (e.g., store construction, consumer information on products, etc.) are further processed by the company APF DIGITAL AGRIFUND CR s.r.o. for up to 2 years (from the end of active communication with the journalist) in order to contact the journalist in situations where it is necessary to protect its rights and legally protected interests (e.g., to properly inform the public). Personal data are therefore processed without the journalist's consent.

9.3. In this case, the processing of personal data will be carried out by the company APF DIGITAL AGRIFUND CR s.r.o. itself or, in accordance with the applicable and effective legal regulations, by a third party, in particular a company from the APF GROUP.

Other data protection rights

10.1. The processing of personal data by the company APF DIGITAL AGRIFUND CR s.r.o. does not involve decisions based solely on automated processing that would have legal effects or otherwise significantly affect the data subjects whose personal data the company APF DIGITAL AGRIFUND CR s.r.o. processes pursuant to this Privacy Statement.

10.2. Data subjects whose personal data are processed by the company APF DIGITAL AGRIFUND CR s.r.o. are entitled to the following rights related to the

processing of their personal data, subject to the fulfilment of the prerequisites set out in the legislation:

(i) the right of access to personal data consisting in the right to receive, free of charge upon request, information on which of their personal data are processed by the company APF DIGITAL AGRIFUND CR s.r.o.;

(ii) the right to rectification of their personal data processed;

(iii) the right to have their personal data processed erased;

(iv) the right to restrict the processing of their personal data;

(v) the right to portability of personal data;

(vi) the right to withdraw consent to the processing of personal data at any time, if consent is the legal basis for the processing of personal data in question.

10.3. Data subjects whose personal data are processed by the company APF DIGITAL AGRIFUND CR s.r.o. also have the right to object to the processing of their personal data if the legal basis for the processing is the legitimate interests of the company APF DIGITAL AGRIFUND CR s.r.o. (i.e., in the case of processing personal data for internal administrative purposes of the APF GROUP or for protection against possible litigation).

10.4. The aforementioned rights, as well as complaints, may be exercised by data subjects whose personal data are processed by the company APF DIGITAL AGRIFUND CR s.r.o. in writing or by e-mail to the company APF DIGITAL AGRIFUND CR s.r.o. as the personal data controller, using the contact details provided in Article 10 below.
